#### **Progress summary...**



### **Pilot No. 2: Kappa FuturFestival**

Pilot No.2 took place on 30th November at the Parco Dora in Turin. The scenario was based around the Kappa FuturFestival held every year at the Parco Dora, a large music festival that attracts thousands of mainly young people over a weekend in July. The primary objective of the Pilot was to conduct a simulated terrorist car attack on a soft target, serving as a practical test for the now more maturely developed tools within the project. The event was meticulously planned to incorporate the key elements of the park and the transition from the outer queue through to attackers' attempts to enter into the densely populated festival.

The key tools tested within the pilot included: online content analysis, real-time video analysis for the identification of logos, weapons and objects, crowd analytics and threat intelligence. It also incorporated reporting and notifications via the crowd sensing app, and overall monitoring and coordination of the





#### **Pilot Format**

- Step 1: Threats are made against the Festival on social media ahead of the event.
- Step 2: As people queue, a vehicle rams the crowd and the driver tries to reach the covered area.
- Step 3: The attacker continues, brandishing a large knife.
- Step 4: Inside, people try to hide, while some fall and are injured during the escape.

#### **Outcomes**

Pilot 2 was the final APPRAISE pilot with the opportunity to test the tools at their most mature stage. The project was fortunate to have several members of the press in attendance to publicise the results.

A huge number of APPRAISE technologies were deployed in tandem to carry out the full pilot with attendance from the local stakeholders to enact the scenario.





#### **Security Research Event**

In late October, APPRAISE was fortunate to share the projects' results at the Security Research Event (SRE) 2023 in Brussels. SRE is an annual event where industry, research, policymakers and practitioners in the security domain come together to discuss the state of play and current challenges for security research in Europe.

Representatives from across the consortium were on hand to share the results of the project so far, with the booth set up to present the videos from the pilots so far and the overviews of the different tools created within APPRAISE.

#### **Professor Ruth Fee PFHEA**

**Organisation:** Ulster University

Bio: Professor Fee is a Professor of Public Services Education and Director of Policing at Ulster University. Professor Fee has a worked on a series of European Commission projects within the security domain contributing to the development of social, ethical, legal and privacy framework across a diverse portfolio of projects encompassing policing, counterterrorism, cyber security and digital forensics. Projects within the H2020 portfolio include INSPEC2T, ASGARD and GAP with current membership inlcuding ITFLOWS, APPRAISE and RESCUER.

#### **APPRAISE Final Event**

The APPRAISE final event took place at MAI-ISCPSI in Lisbon, Portugal from 21-22 February 2024 titled: Securing the Unfortified: Navigating the future of counter-terrorism with a focus on soft target resilience. The two-day event marked the successful culmination of the APPRAISE project, brought to light key insights into the ever-changing challenges of security & safety facing public spaces, and provided an opportunity to share the results of APPRAISE with the wider stakeholder community.

Day one provided an overview from the MAI-ICSPI and the APPRAISE consortium with a hands-on technology fair demonstrating several of the APPRAISE tools. The afternoon sessions focused on the outcomes and results from the four APPRAISE pilots.

The second day involved speakers from the APPRAISE Consortium and Community. Discussions included:

- The collaboration between public and private security operators, countries, sectors and technology providers all seen within the project.
- The societal aspects of the project, such as surveillance, privacy and freedom and its interaction with the protection of public spaces.
- The importance of training, to improve the protection of public spaces.







#### **Event summary**

With over 150 participants, attendees included the APPRAISE Advisory Board, sister projects, external collaborators and students and police officers in the area of the protection of public spaces. MAI-ISCPSI live streamed the event on both their Facebook and YouTube channels with over over 400 attendees watching the event online.
